1. PUBLIC COMMENT

- 5.1 Rick Combs, Investment Board staff, noted that contributions to the Retirement Benefits Investment Fund totaled almost \$1.4 million for the second of Fiscal Year 2024 with a majority of that amount coming from the Las Vegas Metropolitan Police Department OPEB Trust. The City of Reno and Washoe County also made contributions. Withdrawals for the second quarter totaled only \$300,000. Mr. Combs noted that withdrawals were made by three participating entities: the Tahoe Douglas Fire Protection District and both Truckee Meadows Water Authority Trusts.
