Re: Critical Labor Shortage

Employers may be recruiting and hiring retirees into Critical Labor Shortage positions they may not be eligible for. NRS 286.523 does not apply to retirees that have retired with an early age reduction and/or have not reached the age in which they could have retired without an early age reduction.

For those who qualify for Critical Labor Shortage positions, they cannot accept job offers or employment until after the issuance of their first retirement payment. The acceptance of a job offer or employment contract prior to the first payment, OR accepting a Critical Labor Shortage position in which they do not qualify for, will result in the member not being eligible to retire and/or the suspension of their benefit.

Attached is the revised Retiree Reemployment Notification PERS Eligible Position form. The revised form includes additional language regarding a PERS retiree returning to work in a critical need position.
